## **Code of Conduct**

The Code of Conduct guarantees the quality of higher education provided to international students in Dutch higher education. Only students who have enrolled at an educational institute which has signed the Code of Conduct are eligible for a study visa.

### Pre-bachelor

We offer a pre-bachelor programme which includes intensive English language classes together with intensive lessons in the foundation subjects. A minimum IELTS level of 5 is required for entry to this programme.

# **Financial Support**

All Dutch and EU students can apply for study grants and financial support. To apply for financial assistance or a grant, students should first register with DUO. This procedure applies to all students entering a programme at a Dutch accredited and recognised university or institution of higher education.
